- Teamed up with the Department of Health (ESF 8) to staff the Sun Dome along with 20 other shelters in Hillsborough County; serving as the point of contact for shelter managers to be able to open their site location and operate their shelters by troubleshooting problems in the field.

- Helped staff Points of Distribution (PODs) for the distribution of food and water to residents.

PROJECT HISTORY

2026 February* **Hurricane Emergency Action Response Training (HEART):** Led the development of the HEART training for our refugee and migrant communities to increase their level of preparedness for the upcoming hurricane season in partnership with the Refugee and Migrant Woman’s Initiative (RAMWI), the University Area Community Development Center (UACDC), the Disaster Response Ministries International, and Boricuas de Corazon for the Spanish HEART workshop with 25 attendees and 10 students supporting the training as facilitators, translators, and evaluators. Then, the HEART workshop for Arabic and Afghan residents included collaborative efforts with RAMWI, Radiant Hands, Tampa Women’s Star, and 200 Muslim Women Who Care, with 14 attendees and 8 students supporting the training as facilitators, translators, and evaluators. The training includes a walkthrough of developing a disaster plan, how to cope with the stress of a disaster and helping others, how to respond to medical emergencies, safety considerations in flooded areas and damaged buildings, and more. USF students developed a table-top exercise, mental health exercise, hands-only CPR, stop-the-bleed skills, and leadership training, *grant-funded*.

2023 December* **City of Tampa Special Events Mass Casualty Incident Full Scale Exercise:** Served as a member of the exercise planning team in partnership with the City of Tampa Fire Rescue/Emergency Management and the Tampa Police Department in the development and facilitation of a Full Scale Exercise for over 25 agencies designed to test capabilities of cross-agency collaboration of responders in neutralizing the threat of multiple shooters and hostage situation while addressing the needs of medical surge to include triage, treatment, transport procedures, surge capacity for the local hospital system, marine transport of wounded victims, communications of onsite responder and hospital staff, and the capabilities of a Family Assistance Center for maintaining communication, *grant-funded*.

2023 June* **Refugee and Migrant Women’s Initiative WEL Institute:** Led the development of the 2022 WEL Institute Strategic Plan, along with the design of a logic model, SWOT analysis, annual budget, and developed a series of grant proposals for program funding. - Overall, we were able to make an impact on 148 people across four programs under the WEL Institute in fiscal year 2022. This included 76 refugee women from 14 different countries completing 613 training hours. Additionally, we employed 15 interpreters through RAMWI, primarily from the refugee community, to assist with interpreting five different languages, providing a total of 123 hours of interpretation. Furthermore, 47 program volunteers (95% USF students) served as support staff and collaborated with 10 different community partners, serving a total of 558 hours (value of \$17,744.40 at \$31.80 per volunteer hour served).
