I am mentoring a senior year pulmonary fellow (Israel Ugalde, DO) on a project that investigates the impact on asthma outcomes from and preferences for telehealth vs in-person appointments among Black and Latinx adults with moderate to severe persistent asthma. He contributed to our successful ACAAI foundation grant for this project, for which we have now submitted its abstract for the ACAAI 2022 annual meeting. I guided him on successfully presenting to the PREPARE publications committee for approval for multiple components of this project (qualitative analysis of asthma outcomes, survey study on patient preferences for telehealth vs in-person visits). I am guiding him on working with the telehealth working group, which has among its members the president of the American Academy of Allergy, Asthma, and Immunology (AAAAI), and other internationally renowned investigators in clinical asthma research, which will serve him well should he pursue a career in academic medical research.

I mentored a senior Internal Medicine resident (Prajwal Dara, MD) in an ancillary study of the PREPARE trial, which investigates differences in asthma morbidity outcomes between Latinx subgroups of adults with moderate to severe persistent asthma. Dr. Dara has helped formulate the problem, generate the hypotheses, define the study variables and statistical analysis plan, work with statisticians and others in the working group to review, analyze, interpret and present the data. This work has been accepted for publication with the Journal of Allergy and Clinical Immunology and chosen for the research highlights section.

I meet with the Allergy and Immunology fellows on a monthly basis to review their progress in their fellowship research projects, troubleshoot any issues, and provide general research or career mentorship and advice.

I regularly teach Allergy and Immunology fellows and Internal Medicine residents through research and clinical presentations for the AI fellowship morning meetings, the Pulmonary Division noon conferences, the noon conferences of the TGH Internal Medicine residency program, the annual Allergy and Immunology bootcamp session, and the annual USF Allergy and Immunology Symposium at CAMLS.

I regularly teach Allergy and Immunology fellows in the context of in-patient consults.
