Aims: Our Aim is to evaluate the rapid transition to obstetric telemedicine in the response to COVID-19 using the Consolidated Framework for Implementation Research (CFIR) model from two distinct viewpoints: Aim 1) perspectives of patients and Aim 2) perspectives of providers.

Aim: Implement telehealth in a low-income, community clinic. We will implement a prenatal care systemwhich incorporates a hybrid of in-person and virtual visits administered by prenatal care providers. The goal of the model of care is to reduce barriers to prenatal care access and decrease risk of COVID-19 exposure during pregnancy by reducing the number of in-person clinic visits. We hypothesize that we will have increased uptake in the number of prenatal care visits conducted virtually compared to our current numbers.
