Typical referral questions involve whether or not an instant accident / injury resulted in neurocognitive or psychological sequelae (e.g. carbon monoxide or other toxic exposure, head injury, traumatic event) with the main goal of describing cognitive and emotional status, impairment rating recommendations, treatment recommendations, and/or vocational or educational planning.
- <u>Insurance Companies or Worker's Compensation Carriers.</u> Typical referral questions include whether or not there are neurocognitive sequelae following an accident or injury with the main goal of providing assistance with vocational rehabilitation and treatment planning.
- The Court. (By Court Order). Competency Assessments, Intellectual Assessments, Psychiatric / Psychological Evaluations, Insanity at the Time of the Offense Assessments, Capacity Assessments, in which the capacity to make decisions (medical or legal) is assessed.
- <u>Criminal Attorney (Prosecution or Defense)</u>. Assessments for Mitigation of Sentencing (Downward Departure), Dual Diagnosis Placement, Understanding of Miranda Rights, Assessment of Victim for Developmental Disability (for sentencing of defendant) District and Federal Courts. Regional Counsel referrals accepted.
- Other Referral Sources. Occasionally, neurologically compromised individuals (those with head injury, stroke, epilepsy, dementia, Parkinson's, etc.) or neuro-cognitively compromised individuals (developmentally delayed, mentally retarded, language impaired,

attention deficit disorders, autism spectrum disorders) are referred for cognitive assessment in order to determine their capacity and/or competency status. Such capacities include ability to make medical/financial decisions, to testify relevantly, to understand / participate in courtroom proceedings, to communicate effectively (receptive / expressive language, etc.

An IME/CME is usually requested to determine the presence or absence of neurocognitive and/or psychiatric impairment, to assess their relationship to a specific event, instant accident or injury, and occasionally to assist with treatment planning.

An IME / CME may be requested to determine disability status for the purpose of obtaining disability benefits and / or permanent impairment rating recommendations. Although psychologists in the state of Florida do not provide permanent disability ratings, neuropsychological testing can provide the data on which the basis of permanent disability ratings can be determined by a statutory-accepted clinician (e.g. psychiatrist, neurologist, etc.).

<u>Caveat</u>: The neuropsychologist attempts to answer specific referral questions related to brain-behavior relationships. The neuropsychologist's role is to "conduct a proper examination" (Ethical Standard 9) and practices only within the bounds of professional competence (Ethical Standard 2) consistent with the American Psychological Association Ethics Code (American Psychological Association 2002).
